

NAILSEA TOWN COUNCIL COMMUNITY ENGAGEMENT COMMITTEE

Minutes of the meeting of the Community Engagement Committee held on Wednesday 3 May 2017 at 7.30pm in the Tithe Barn, Church Lane, Nailsea.

<u>PRESENT:</u> Cllr Packham in the Chair, Cllr Barclay, Cllr Bird, Cllr Hamblin, Cllr Heappey, Cllr Lees, Cllr Petford, Cllr Wilson and the Clerk. Also in attendance Cllr A Tonkin.



CE26/17 DECLARATIONS OF INTERESTS: None.

CE27/17 MINUTES of the meeting held on 8 March were approved as a correct record and signed by the Chair.

CE28/17 FINANCIAL MATTERS

Noted.

CE29/17 TO CONSIDER AN UPDATE ON THE NAILSEATOWN.COM PROJECT

Cllr Bird reported that following the meeting with the Town Council on 12 April, Squarebird went back and worked on the logo, taking on the feedback given. Squarebird have now come back with an updated design which he circulated to the committee. He explained that this design was a concept, not simply a logo, and will be used to brand the whole project. He said the design fits into a square which is important for web use and social media.

The Clerk added that this design was a development of the one chosen by the Council. The colour is more vivid on the screen than in print and this is where it will be primarily used.

Cllr Heappey was concerned that the logo looked similar to that of another company but it was pointed out that there will always be similarities with any logo.

Cllr Packham explained that the next stage was to start developing the website.

CE30/17 CONSIDERATION OF THE NAILSEA PLACE INITIATIVE

a) To consider the minutes of the Nailsea Place working party, 14 March 2017 Cllr Lees referred to an earlier meeting with FoReal where they had explained that often there would be a greater number of users within a particular age range for a year or two and then this would change. He asked if there as a particular age or year group attending Youth Club currently.

The Clerk advised that now the top floor was specifically for the Youth Club and they have been able to make the space work better for them this may appeal to a broader range of young people.





Sessions are generally aimed at young people aged eleven and up and it was suggested that perhaps an additional session could now be provided to be aimed at a younger age group.

There was discussion around the need for improved publicity and promotion of the Youth Club within schools. The Clerk pointed out that until recently there was concern Youth House would be lost. Now that the building had been purchased by the Town Council and the Youth Club has made a home on the upper floor FoReal could be clear on what exactly they were offering and could promote the Youth Club more confidently.

b) <u>Consideration of a draft proposal from 2BU Productions for an Arts and Health</u> Initiative

Cllr Tonkin reported that the working group were currently looking at what is available in terms of workshops and events at no.65. Elspeth of 2BU has a lot of ideas that the group would be keen to use and it would be good if she could be used to set up an initial project.

The Clerk said that Elspeth has connections and works within arts network. It would be beneficial to get some momentum at this stage. Elspeth is in talks with the Leg Club about running a session there and has had discussions with Carole Brook about the potential for a Respiratory Club that would operate in a similar way to the Leg Club.

The Clerk reported he had been in contact with Tom French of the Good Things Foundation. They are currently working with NHS Digital and offering grants for the Pathfinder Project to improve people's digital skills, which will help individuals to manage their health better; from ordering repeat prescriptions, online to following up on advice given by the GP. The Good Things Foundation have funding for twenty projects over the next three years and Nailsea Place will be one of these. The funding is £50,000 over twelve months but Nailsea Place will need to be operational by October. This is a new concept with no template but there is an understanding in the NHS for the need for innovation.

Cllr Lees asked if there was a proven track record for 2BU that could be seen and the Clerk confirmed that Elspeth had successfully run workshops in various settings.

Cllr Tonkin said that £30,000 had been budgeted for establishing Nailsea Place. The physical works planned for the building at this stage were minimal and the priorities were setting up wi-fi, removing the suspended ceiling, getting the roof and electrics checked and some decoration. She suggested that a good use of the budget would be to invest in some initial workshops or projects.

It was agreed that getting things started would prove the concept works and help to attract further grant funding.

It was proposed by Cllr Lees and seconded by Cllr Wilson

RESOLVED:

to RECOMMEND to Town Council that £10,000 of the £30,000 already allocated to establishing Nailsea Place should be budgeted for initial projects and workshops to be agreed by the working party.

The vote was unanimous.

CE31/17 65 HIGH STREET

a) Update on the purchase

The Clerk reported that the contract had been signed and it was hoped North Somerset Council would be signing in the next two weeks.

b) Update on the Youth Service

It was agreed this had already been covered under agenda item 6. a).

c) Update on the cost of installing wi-fi

The Clerk said it was going to be necessary to install a leased line in order to support the Pathfinder Project and any other digital workshops. This would incur a significant monthly charge but it was hoped this could be covered by the project funding.

CE32/17 CONSIDERATION OF A PROPOSAL BY NAILSEA AND BACKWELL ROTARY CLUB TO RENAME THE 'ROTARY ROUND' ACCESSIBLE ROUTE TO THE 'DAVID WHITTLESTONE ROTARY WALK'.

Cllr Lees said this walk was not to be confused with the 'Nailsea Round'; David Whittlestone had plotted a walk on pathways that was fully accessible to all including individuals using wheelchairs or pushchairs.

It was proposed by Cllr Wilson and seconded by Cllr Heappey

RESOLVED:

to support Nailsea and Backwell Rotary Club in renaming the Rotary Round as the David Whittlestone Rotary Walk.

The vote was unanimous.

The report was noted and it was observed by Cllr Lees that expenditure for rent and service charges was significant.

Cllr Petford shared ideas for furniture at 65 High Street. To ensure flexibility, tub chairs and two-seater sofas were favoured as well as other chairs of different heights and

design to co-ordinate. Ikea furniture was being considered as it is easy to create adaptable areas for different uses for a low cost.

Hot drinks machines are still being investigated but it was agreed that a £1 charge for drinks seemed reasonable. Consideration was given to not wishing to cause issues for local cafes whilst ensuring the drinks were affordable to all users of the building.

- 4. 65 High Street
- a) Update on the purchase

lan reported that almost all the required documentation is in place, and the local authority searches had not raised any concerns. The only remaining issue is the need to resolve some hopefully uncontentious issues regarding the boundary.

b) Actions from previous meeting

- i. Ian reported that internal and external surveys of the building have been completed. The architect who designed the Glassworks scheme (Martyn Lonsdale) has been asked to quote to carry out some design and project management works. In the first instance the GVA condition report of March 2016 will be used to establish priorities for maintenance and repairs.
- ii. In the short-term a major investment in the kitchen could be a mistake, as the long-term needs of the building are not known. Ian suggested that a hot drinks machine could be leased on a short-term basis. Saeeda commented that this needs to be simple to operate and accessible for people in wheelchairs.
- iii. It was agreed that in the early stages the building should be open for people simply to come and visit, and should include a suggestion board for ideas for initiatives.
- iv. Initially, the building will have to be managed through a combination of office staff and volunteers. As the requirements develop this will need to be reviewed.
- v. A database of contacts will be developed, including ideas for Nailsea Place initiatives.
- vi. Ian said that he has been approach by Vicky from Two Left Feet, who use the Barn for dance and drama for people with learning disabilities. Vicky has a number of ideas for classes which she would like to try out, and thinks that No 65 would be a good venue.
- vii. Installing wi-fi is a priority, which lan said he would organise.



viii. Ian said he would produce a simple project plan to capture all the agreed tasks and would prepare a budget for consideration by the Council as further information becomes available.

c) Youth Club

Karen Pike and the young people are keen to relocate upstairs and to make the space their own. This would include moving the furniture from downstairs and painting walls. Ian referred to an email he had received. Karen said "We have come up with a loose plan with young people for moving upstairs, we have spent some time looking at the zones they wish to create its really great as will still give us a lot of flexibility to move things push things back to the wall and have a good space, if we wanted to dance or be a bit active. The zones they are considering are

- Sports/Table tennis zone
- Gaming zone
- · Chill out zone
- Group work / computer zone

d) Consideration of purchasing furniture for the ground floor

- a) The existing furniture in the building is not suitable to create a welcoming environment for people of all ages. It was agreed that the objective is to aim for a relaxed feel along the lines of a 'Costa Coffee' shop as opposed to a functional council/office atmosphere.
- b) There needs to be chairs with arms, but also comfortable sofas. Helen said that high chairs also need to be available for children.
- c) Cllrs agreed to look at options for furniture.

5. Actions from the workshop on 3 March

- a) The workshop had highlighted that Nailsea Place should evolve steadily, and be flexible in responding to demand as it emerges. The vision will therefore become reality on an incremental basis. It is vital that 65 High Street does not become dominated by any single group or small number of organisations.
- b) Ian said that a major action for him was to try and get an academic research organisation to get involved in assessing the benefits of Nailsea Place. It is obvious that the NHS and social care sectors remain unwilling to fund initiatives relating to social prescribing and wellbeing, and much of this seems to relate to a lack of hard economic evidence, even though qualitative research highlights the benefits to individuals and their families. He is waiting for responses from various people he has approached.
- c) Clare said that it was clear how important it is to use digital technology to assist hard to reach groups, and that young people could be a vital part in this.
- d) Ian reported that he has a site meeting organised with Malcolm Rigler and Elspeth Penny on 30 March to discuss workshops that Elspeth is considering putting on at No 65. She attended the conference and is involved in the arts and health sector, which should be an important part of Nailsea Place.
- e) Ian mentioned that Mitzi Blennerhassett had written a short article following the workshop which he had sent to the Society of Local Clerks, hopefully for inclusion in their magazine 'The Clerk'.

f) A follow-up workshop should be organised when No 65 is open and operating, to review progress in implementing the vision. Ideally this would include a research group.

6. Any other business

- a) It has been suggested that the railings outside the building be removed as they create an unwelcoming environment.
- b) It was hoped that young people would maintain the planting area, as they had done for Nailsea in Bloom some years ago.


1. Aim of proposal and project: Creating a part time funded position for Nailsea Place Cultural Development Lead and defining a project.

This would be an early reconnaissance project, leading to some suggested "next steps".

The job:

- Create an open meeting for all interested parties to attend and explore/brainstorm arts-in-health possibilities and put forward ideas.
- Meet with members of the Nailsea community, patients, people
 with mental health conditions etc. Visit the Leg club and run one
 workshop there, along with Bristol University's Life of Breath
 Project Letter to my breath. This could potentially lead to a
 regular writing a letter to my breath workshop at the Leg club.
- Research existing projects to learn from successes and failures/what can be done better. Examples include Bromley by Bow; Hazel Stuteley's Falmouth project; Pioneer Projects and volunteer led libraries (eg in Bath). Also arrange visits — a group of people key to the project - to these projects.
- Research and create lists of artists and artistic projects to enlist in the future.
- Work holistically with the Nailsea Place team towards creating a skeleton facility at 65 High Street, including discussions about architects and use of space.
- Liase with Squarebird (Jon and Nick Bird) about a social media output concerning the project, on Nailseatown.com and other platforms such as Twitter, Instagram and Facebook.
- Have a 'Try out, review, repeat or not do again' approach to the initiative.
- Retain a playful, enjoyable approach, to entrance people to join in!

Learning from existing arts-in-heath projects...



In addition to the above: Grow...

- My/our existing contacts in the NHS, health and in existing arts-in-health projects, forums and with arts-in-health practitioners.
- Existing collaborations and relationships between local organisations such as The Leg Club (Carole Brooke); Theatre Orchard, Nailsea and Backwell Children's centre; Schools in Nailsea; Dr Mary Backhouse, chair of the North Somerset Clinical Commissioning Group etc.
- Relationships with Nailsea NHS practitioners, such as Dr Rees, health visitors, pharmacists, nurses, carers. Also Citizen's Advice, librarians etc. Seek advice and support from professional organisations such as Lapidus, the UK organisation for writing for wellbeing and groups that I belong to such as 'Healing Matters' in Exeter and Arts and Health forum in Bristol.
- Relationships with national organisations such as The Patients Association (Heather Eardley), The Good Things Foundation (Tom French), and innovative individuals such as Raj Adgopul who is a health visitor developing an app and social media to promote health and well being – keeping the project connected, innovative and up to date.

- Existing academic links with academics such as Emeritus Prof Paul Dieppe at Exeter, Dr Andrew Edgar and Dr Peter Sedgwick at Cardiff University, The School of Social and Community Medicine and Medical Humanities, at Bristol University, and make new ones with eg Prof Antony Morgan Dean GCU London. This will help take the project to national level, bring in national interest and credibility.
- Research or enlist other agencies/people to research funding sources, which might be available to the town council to secure long term future of the project. This would include NHS General Medical Practice Research fund; NHS Innovation fund (with advice from The Royal College of GPs) and NCVO and the team at The Patients Association that are focused on fundraising. Perhaps a person from REACH could help with this.

Create...

- A Steering Group to meet 3 times a year (members to include those living locally and with a special interested in Nailsea Place Arts and Health Initiative).
- A Supportive group of additional interested people.
- An annual workshop in the fashion of March 3rd 2017 to encourage new people to get involved and engaged, and retain diversity.
- A great title for the project.
- A realistic but ambitious proposal for a 2-3 year project, with view to it having continuity into the future; linking into ideas of how it might be evaluated, and how the ideas will be shared nationally and perhaps internationally.
- A guide book and/manifesto to keep perspective on the main goals: eg to create values – eg down to earth; welcoming; non hierarchical; allowing expression; creative; to tackle isolation (in all ages); diversity; inclusivity; transparency; working towards greater health and wellbeing of the communities in Nailsea; working with art and creative projects to achieve the goals; building and retaining inspiration and enthusiasm within Nailsea; make it fun; to be a flagship project to attract National and International interest.

2. I also suggest this first arts-in-health workshop series: 'Letter to my grandchildren and other young people'.

This is a series of 8 weekly workshops. 12 older people are invited to attend to create their own personal book on an i-pad, using photographs, pictures or images of their own past (and future dreams), and a photo of a hand-written or drawn letter 'to my grandchildren', including photos of the grandchildren. The book will then be published. Participants will end up with:

- Experience with ipads/technology, and overcoming their resistance and/or fear of technology, using pre-provided ipads or computers.
- A certificate from the Good Things Foundation, or similar certificate.
- An insight into other areas of the Internet, such as health advice.
- A community experience, tackling the isolation of some participants.
- The option to continue meeting together.

Teenagers (including grandchildren!) will be invited to volunteer to help. It will be made clear that people with little or no literacy skills are more than welcome to join in the project.

The Good Things Foundation will be consulted about this project and a local experienced i-pad/technology workshop leader enlisted for some of the sessions. We might ask Artist David Hockney to drop in to share some of his wisdoms for art on the ipad!

3. Outline of how this reconnaissance project would lead on to three further phases:

Nailsea: Phase 1

4 primary needs in Nailsea we can address...
Under 5's, school readiness
Lack of connectiveness to the internet
How to help teenagers pass though a difficult time
Loneliness and disconnection amongst the elderly.

So in different ways, we are bringing communities together to promote health and wellbeing.

What is the best way to address them?

- Offer art classes for parent/carer and toddler?
- · Use photography or film projects, and hobbies: 'make learning fun'.
- · Film club showing good films and making films.
- Leg club storytelling and collecting oral history/ Link in with primary schools?

What next? Phase 2

Communities within Nailsea working together, along with their health visitors, GP's and the town council, bringing in projects as the needs develop and change

- Dance
- Writing Workshops eg 'Creative Sparkle'
- Knitting club
- Life drawing
- Letter to my breath, to my bones, to my heart, to my blood...
- · Choir
- Theatre group
- Etc.....

Phase 3: Nailsea Place - a flagship cultural development centre for health and wellbeing

- Quarterly event in the Tithe Barn, where North Somerset projects are showcased. Made available for members of the society of town clerks around the country.
- !! Nailsea Arts Festival !! Gathering a community together to create and run a festival.

Minutes 12TH Annual General Meeting

Friday 8th April 2016 3pm. Nailsea Fire Station, Pound Lane, Nailsea.

In attendance: Chris Baker (CB), Lin Baker (LB), Chris Sumpter (CS), Michel Limpinnion (ML), Dave Roberts (DR), Maggie Parnell (MP), Carol Bluett (CB), Carol Haughton (CH), Helen Read (HR), and Chris Morris (CM).

Apologies: Sean Kelly, Jackie Uren, Clare Hunt.

Agree minutes: MP and ML agreed the minutes of the last meeting.

Chairman's Report: Chris Baker.

CB reports that it has been another challenging year. He is finally stepping down as Chairman from today, but will continue to advise until the end of May, because he has three appeals to finish.

The office has been very busy, and numbers of clients have gone up. There have been 655 appointments including home visits, and 373 telephone calls.

In the last couple of years, the government has made some change to every single benefit. They have also not raised benefit payments by the rate of inflation, which is in effect a cut. Disabled people are financing the Government's living wage, and a lot of disabled people are dissatisfied and upset, and are coming to us for help. Pension Credit will be frozen for five years, so the government are taking money from these people too.

Every one of our volunteers is there because they choose to be, and are doing more than they originally signed up for.

CB thanked everyone for their brilliant efforts. He thanked Chris Sumter for stepping forward to take over the running of the office from LB and himself. He thanked Chris Morris for doing the accounts and for all his good work for them since the office opened in Nailsea in 2003. LB then gave him a gift.

CB then mentioned the contribution of the Bristol law College and the help of Amanda Crutchley in supplying the NDI with such high calibre law students every year. They have all been brilliant and have thrown themselves into everything we have asked them to do.

Then CB thanked most specially his wife Lin for her unwavering support for helping him found the initiative and her very important hard work and expertise in the development and running of the centre. He said that since it was first established in Church House, it would have been a much more challenging job without her. Chris presented Lin with a bouquet, with his thanks for all her work over the last 13 years.

Then CB asked Chris Sumter to say a few words of introduction. We learnt that she came to live here from Spain about a year ago, where she had been running the Spanish Samaritans for many years. She is well travelled and has a background in education and psychotherapy. In Spain she managed 70 volunteers and will be bringing that experience to running the NDi.

Then CB talked about when he first met Sean Kelly, who was absent from the meeting as he was recovering from an operation in hospital. When he first met Sean he came into the office when the computers were down, and gave CB his card. CB explained to SK that NDI was looking for volunteers and SK said he would come. He looks after the computer system and has taken on the very important job of approaching trusts and foundations for funding, which has to be done every year. He always attends fetes and stores the gazebo and tables in his garage. He is amazing and a very nice bloke.

LB read out a letter from Sean, (who has been put forward as the new Chairman), He said that he had really wanted to be there, and he thanked Lin and Chris for allowing him to volunteer and for all their dedication and work for the community over the years.

CB finished his report by saying that he has enjoyed his time as Chairman of NDI, even the ups and downs. He thanked Nailsea Town Council for their help. He thanked CS for taking on the running of the office. He thanked SK for accepting the role of the new Chairman, and said that for him it has always been about serving the community, and not about CB.

LB then thanked Chris for his contribution to the community and work over the years and talked about how, after his disablement, he took up charity work. He did not retire, but first worked at St Peter's Hospice, then at Dial, where he met John Broomhead. Without John's help the NDI would not have happened, from a little acorn it turned into an oak tree. Chris has done everything head cook and bottle washer. Thank you for helping the community and doing what you have done.
